ALL CUSTOMERS:

In consideration of listing for sale and undertaking to find a purchaser of the vehicle described herein, I or we, here by grant and give G. Potter King, Inc. d/b/a GPK Auctions, the exclusive right and authority to sell said vehicle from the start of the event to 14 business days after the conclusion of the event. It is understood and agreed that GPK Auctions is simply an agent for the seller and is not apart of any agreements between the buyer and seller. Vehicles are auctioned by a licensed and authorized independent auctioneer only.

*VEHICLES WILL NOT BE ALLOWED INTO THE AUCTION AREA UNLESS ENTRY FEE IS PAID IN FULL.

ENTRY FEES:

Are not refundable for any reason and are not applicable towards any commission.

EARLY EXIT POLICY:

Removal of vehicles by the Seller prior to the conclusion of the event is not permitted under any circumstances. By signing this form I agree to be charged an early exit fee of \$500 if I do not adhere to this policy. I understand that there will be NO EXCEPTIONS.

AUCTION DAY POLICY:
