All Corral Exhibitors agree that their exhibit space(s) will be occupied during the entire above listed and nationally advertised show hours, in order to serve visiting buyers that attend the event. No deviation from the hours will be allowed. G. Potter King, Inc. d/b/a GPK Auctions reserves the right to modify the above schedules hours. GPK Auctions will not be responsible to the applicant for any modification of the schedule.

ENTRY FEES:

Are not refundable for any reason. Corral Exhibitors will not be allowed into the event unless entry fee is PAID IN FULL.

EARLY EXIT POLICY:

Removal of exhibit vehicles (other than those sold) prior to the conclusion of the event is not permitted under any circumstances. By signing this form I agree to be charged an early exit fee of \$500 if I do not adhere to this policy. I understand that there will be NO EXCEPTIONS.

SAFETY REGULATIONS:

Corral Exhibitors agree to use and occupy their exhibit space(s) in a safe and careful manner, and to comply with all laws, rules, regulations and ordinances which may apply, as well as all rules and regulations relating to the use of the Center and GPK Auctions. Corral Exhibitors further agree not to do any act or allow any act to be done which will in any way mar, deface, or injure any part of the Convention Center. Corral Exhibitors agree to be responsible for any damage to walls, ceilings, pillars, etc in their rental area which result from the use of nails, screws, tape, glue, or any materials that may cause damage to these areas. At the conclusion of the event, Corral Exhibitors will deliver to GPK Auctions the premises in as good condition and repair as they were at the beginning of their occupancy of the rented space(s). Corral Exhibitors further agrees not to allow any loud sound displays. No starting of vehicles during public event hours is permitted.

MANAGEMENT RULES:

Any conduct or actions deemed to be unethical in the judgement of GPK Auctions or any infractions of this agreement on the part of the Corral Exhibitor, employees, or representatives will be subject to dismissal and eviction from the event floor. Corral Exhibitors agree to remove any displays prohibited by GPK Auctions. In the event of any removal or dismissal under this paragraph it is agreed that GPK Auctions will not be liable to the Corral Exhibitor for any damages or expenses incurred. Any expulsion or exclusion of the Corral Exhibitor will be in addition to any other legal rights that GPK Auctions may have arising out of any breach of this agreement.

ALLOCATION OF SPACE(S):

This agreement is subject to acceptance by GPK Auctions. Space(s) is allocated on a first-come first-served basis: however, GPK Auctions reserves the right to exclude any vendor if in the opinion of GPK Auctions such exclusion is in the best interest of the event. GPK Auctions reserves the right to determine space(s) location. Space sharing or subletting is not permitted.

PASSES:

Corral Exhibitors shall receive two (2) exhibitor passes (per space purchases). Additional passes are available at 1/2 the current ticket fee and may be ordered in advance or purchased from GPK Auctions.

EXHIBITOR AGREEMENT:

In the consideration of the disclosed fee and the meeting of all terms set by GPK Auctions, I do agree to rent the agreed upon space(s) at The Atlantic City Classic Car Auction & Show. It is agreed by both parties that the rental of this space(s) does not in any way make the corral exhibitor responsible for any commissions. I agree to rent such space(s) with the express agreement that I will be permitted to sell the disclosed vehicle(s) at a price determined by me, and that GPK Auctions has no responsibility for the sale of said vehicle(s). I agree to hold harmless GPK Auction for any responsibility in the sale of said vehicle(s). GPK Auctions is not part of any agreement of any kind between the buyer and seller.

LIABILITY / PROPERTY INSURANCE / PERSONAL INJURY / OTHER DAMAGE:

Management assumes no responsibility whatsoever for any property in the Convention Center. The applicant agrees to indemnify and hold Management harmless and hereby expressly releases and discharges Management from any and all liability for any loss, injury, suits or damage to person or property that may be sustained by reason of the occupancy of the Convention Center under this agreement. The applicant agrees to maintain his/her own casualty insurance covering any property used or to be located at the Convention Center. The applicant further agrees to purchase and maintain general public liability insurance covering any liability which may arise out of his/her occupancy of space in the Convention Center. Upon request, the applicant will exhibit proof of this insurance to Management. Failure of Management to inspect applicant's insurance policy shall in no way be deemed a waiver of this requirement.
